General Conditions

The following Conditions apply to the use of Brandon Stadium and Leicester Stadium for Stock Car Racing and all testing and demonstration driving in connection therewith:— 1. Neither Midland Sports Stadiums Limited, nor

 Neither Midland Sports Stadiums Limited, nor any Official, agent or servant thereof shall, in any circumstances whatsoever, be liable for any damage to or done by any car or other vehicle brought into or used at Brandon Stadium or Leicester Stadium or for any personal injury or loss, of whatever kind, sustained by the owner or entrant thereof or by any person driving riding in or attending upon such car or other vehicle, whether used during any race or during test or demonstration, or while the said car or other vehicle is on any race track or road forming part of the Stadiums or on any approach thereto, or on land adjacent thereto, or by whatever means such damage, injury or loss may be caused, and even though the same may be caused by the wilful act, neglect or default of any official, agent or servant of the said Company or persons.
No driver or other person or persons as aforesaid shall take part in any race, test or demonstration without having first satisfied himself as to the safety and suitability in all respects of the Stadium, and the owner, entrant, driver or other person as aforesaid shall indemnify the Company and its officials, agents and servants against all liability for any damage, injury or loss so done or sustained as aforesaid.

3. No driver shall take part in any race, unless he is medically fit, and a current certificate by a registered medical practitioner as to the fitness of a driver to take part in races shall if demanded by Midland Sports Stadiums Limited, be produced before such Driver is permitted to race.

4. Midland Sports Stadiums Limited, may in its absolute discretion and without giving any reason therefor refuse to permit any driver or any car to take part in any race, but the fact that any driver or car is permitted to take part in any race shall not be taken as implying in any way that Midland Sports Stadiums Limited is satisfied as to the competence of such driver or the suitability or safety of such car. 5. All owners, entrants, drivers and other persons a aforesaid shall be deemed to have notice of and

as aforesaid shall be deemed to have notice of and to be bound by any Rules Regulations or Instructions which may from time to time be made or issued by Midland Sports Stadiums Limited in regard to races, tests, demonstrations or any other matter or thing in or about Brandon Stadium and Leicester Stadium.

6. It is a condition of entry that all Drivers of cars at Brandon Stadium and Leicester Stadium do so entirely at their own risk and no Compensation in case of injury can be claimed other than under the Schedule of Benefits of Personal Accident Insurance effected by the Midland Sports Stadiums Limited. 7. These Conditions and any Rules, Regulations or Instructions as aforesaid shall be deemed to be

These Conditions and any Kules, Regulations or Instructions as aforesaid shall be deemed to be known to and shall be binding on all owners, entrants, drivers and other persons as aforesaid whether such owners, entrants, drivers or other persons shall have signified their agreement thereto (either verbally or in writing) or not.

Competition Rules and Regulations

1. Crash Helmets.* Approved R.A.C. design Crash Helmets are compulsory and must be worn during racing.

must be worn during racing. 2. Goggles. Goggles, if worn, must be shatter-proof.

3. Safety Belts. Belts must be substantially secured and of strong material with quick release, and must be worn during racing

during racing. 4. Dress.* Overalls must be worn by competing Drivers.

5. Inspection. Cars may be inspected by a Car Examiner at any time before a race.

6. Passengers. No passengers are allowed; Drivers only are allowed with the car on the Track.
